Registration of Suppliers for Goods and Services under Shopping Method – 2010
(Excluding Works and Consultancy Services)

Your attention is drawn to Public Finance Circular No.433 of 26-09-2008, No.433(i) of 26-12-2008 and 433(ii) of 28-09-2009.

02. In spite of having notified in terms of Para 04 of Public Finance Circular No.433(ii) that paper advertisement should not be published for registration of suppliers for the 2010 financial year for public institutions located within the Western Province, it has been observed that many public institutions publish paper advertisements for registration of suppliers for the 2010 financial year. It is hereby informed that in future suppliers should not be registered for goods and services for the year 2010, and to refrain from publishing such advertisements, and also to suspend selection of suppliers from those lists, if advertisements have already been published.

03. However, it is hereby kindly notified that in case where it is necessary to publish paper advertisements for registration of suppliers for public institutions located within the Western Province in respect of items not included in the categories of goods and services for which suppliers have been registered, the Treasury has no objection for publishing paper advertisements having obtained prior written approval from the Department of Public Finance.

04. While informing you to probe and report back to me if any institution under your purview has already been acted contrary to Public Finance Circular instructions and you are further notified to take action in terms of the instructions stipulated in Para 06 of Public Finance Circular No.433(ii).

06. You are kindly requested to inform all institutions affiliate to your Ministry/Department to comply with this Circular instructions.
