Procurement of Supply, Installation, Commissioning and Maintenance of Advance End Point Security Solution for Ministry of Finance IFB No: ITM/2/1/02/NCB/EPS/2022

 The Chairman, Department Procurement Committee on behalf of the Department of Information Technology Management of Ministry of Finance now invites sealed bids from eligible and qualified bidders for the Procurement of Supply, Installation, Commissioning and Maintenance of Advance End Point Security Solution for Ministry of Finance as specified in the Bidding Document.

Contract Period: Delivery & Installation period within **6 weeks** from the Date of Signing the Contract + 3 Years Subscription, Support and Maintenance

- 2. Bidders must meet the following minimum qualification criteria:
 - Participation as a Supplier, in at least One (1) Security Solution project such as firewall or endpoint security, which valued at least LKR 10 Million that have been successfully completed within the last 5 financial years (2017-2018, 2018-2019, 2019-2020, 2020-2021, 2021-2022)
 - Minimum average annual turnover of LKR 100 million calculated as total certified payments received for the contracts in progress or completed, within the last 3 financial years (2019-2020, 2020-2021, 2021-2022).
- 3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the National Procurement Guidelines, and are opened to all eligible bidders as defined in the Guidelines.

Bids will be opened soon after the bid closing in the presence of the bidders' representatives, who choose to attend at 3.00 p.m. on 29th November 2022. All bids must be accompanied by a Bid Security of not less than Sri Lankan Rupees Nine Hundred Thousand (LKR 900,000.00).
- 7. A pre-bid meeting, which potential Bidders may attend will be held in Randora Auditorium, Ground Floor, and Ministry of Finance at 10.00 a.m. on November 15, 2022.
