## Imports and Exports (Control) Act, No. 1 of 1969

IN terms of the powers vested in me by Section 20 read together with Sub-Section 4(1), Section 6 and Section 14 of the Imports and Exports (Control) Act, No. 1 of 1969 as amended by Act No. 48 of 1985 and Act No. 28 of 1987, I, Basil Rajapaksa, the Minister of Finance, promulgate following Regulations.

### REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 05 of 2022**”.
2. The Regulations prescribed in this **Gazette** shall only be applicable to the importation of goods, which have the date of Bill of Lading/ Air Waybill on or after 10<sup>th</sup> March, 2022.
3. Goods, described below together with their corresponding entries, shall be inserted into the **Schedule I** of the Special Import License Regulations, published in the *Gazette Extraordinary* No. 2044/40 dated 09 November 2017, as amended.
4. License shall be issued for importation of goods, specified under the Serial Numbers from 270 to 370 in the **Schedule I** of this *Gazette* subject to the recommendation of the Secretary to the Ministry of Finance.
5. Any importers, who intend to import any goods, specified in the **Schedule I** of this *Gazette*, shall have a valid License, issued by the Controller General of Imports and Exports Control, prior to the date of Bill of Lading / Airway Bill of such importation.
