23rd March – 27th March 2026

REAL SECTOR

- Economy expanded by 5.0 percent in 2025.
- Price of Brent Crude Oil increased by 0.2 USD bbl and WTI decreased by 0.24 USD bbl, respectively.
- CCPI - Headline inflation (2021=100) decreased to 1.6 percent (YoY) in February, 2026 from 2.3 percent (YoY) in January, 2026.
- NCPI – Headline inflation (2021=100) decreased to 1.6 percent (YoY) in February, 2026 from 2.4 percent (YoY) in January, 2025.

- Sri Lankan rupee slightly depreciated to USD 1=Rs. 314.42 from USD 1=Rs. 311.59
- Exports decreased to USD 1,148.7 mn in January 2026 compared to USD 1,157.9 mn in December 2025.
- Imports decreased to USD 1,803.3 mn in January 2026 compared to USD 2,155.2 mn in December 2025.
- Trade deficit
 - USD 654.5 mn in January, 2026
- The gross official reserves stood at USD 6.8 bn as end of January 2026.
- Workers' remittances recorded USD 729.0 mn in February 2026.

- Credit to the private sector increased by 26.3 percent (YoY) in January, 2026

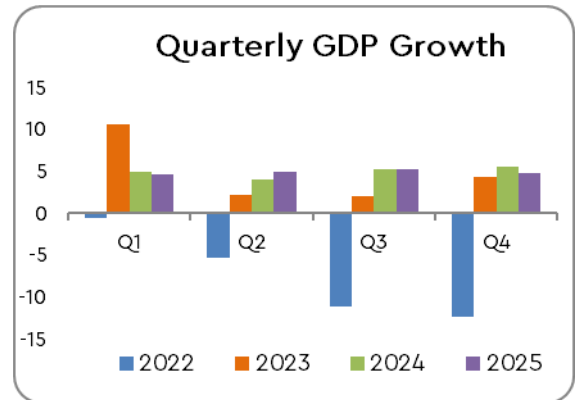

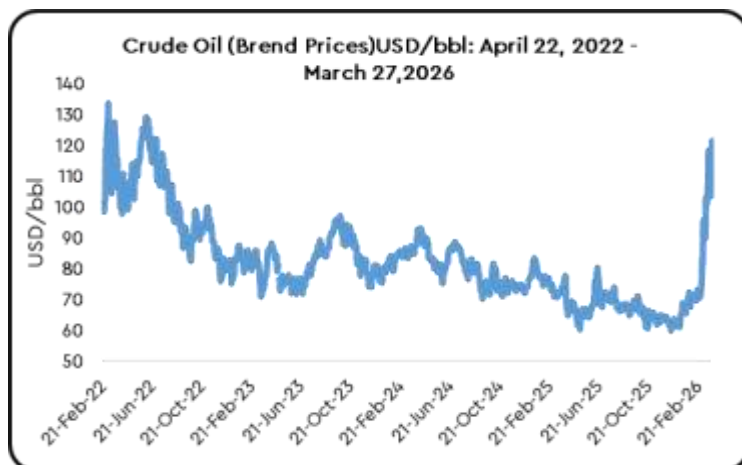
