

Invitation for Bids
Procurement for the Supply 02 Nos. Motor Cars (SUV)
Under Operational Leasing Method

01. The Chairman, Ministry Procurement Committee (Minor) on behalf of the Ministry of Finance, Planning and Economic Development, invites sealed bids from eligible and qualified bidders for the Supply of 02 Motor Cars (SUV) for **24 months** under operational leasing method to the Ministry of Finance, Planning and Economic Development.

03. Eligibility criteria include:
 - i. Vehicle agents who are franchise holders of world-renowned vehicle brands available in Sri Lanka, financial institutes registered under the Central Bank of Sri Lanka or Motor cars (SUV) rental services (i.e. Rent a Car Companies) with at least 05 vehicle fleet and the business must be registered under the Companies Act No.7 of 2007 and subsequent amendments.
 - ii. The bidder shall supply vehicles that have a mileage of less than 50,000 km at the point of hiring.
 - iii. Documentary evidence of experience in supplying a minimum of five motor vehicles under operational leasing method within the last five (05) years.
 - iv. In the Event of a breakdown of the vehicle, the supplier shall provide a similar replacement vehicle within 24 hours.
 - v. All maintenance, licensing and insurance related to the vehicles shall be undertaken by the supplier.
 - vi. The supplier shall provide a vehicle condition report along with the bid and shall arrange a vehicle demonstration upon request.
04. Bidder shall enclose the original and the copy of the Bid in separate sealed envelopes, duly marking the envelopes as “ORIGINAL” and “COPY” These Envelopes containing the Original and the Copy shall be enclosed in one single envelope and write the procurement for the supply 02 Nos. Motor Cars (SUV) Under Operational Leasing Method and Bid Number MOF/Shopping/18/68/2026 on top of the left hand corner of the envelop.
05. Bids must be deposited in the tender box kept in the Accounts Division, Upper Ground Floor, New Building, Ministry of Finance, Planning and Economic Development, The Secretariat, Colombo 01 or dispatched by registered post to the address Chairman, Minor Procurement Committee, Ministry of Finance, Planning and Economic Development, The Secretariat, Colombo 01 to reach at on or before **2.00 pm on 24.08.2026**
