National Budget Circular No: 01/2019

All Secretaries to Ministries, Chief Secretaries of Provincial Councils, Heads of Departments.

Preparation of Annual Financial Statements including the Appropriation Accounts for 2018

Subsequent to the approval of the Appropriation Act No 30 of 2017 for 2018, the Ministerial Structure was revised several times in the year 2018 and certain expenditure heads of 2018 have been completely cancelled while the function of those have been assigned to other expenditure heads . Accordingly, it is requested to comply with the instructions of the General Treasury in preparing Annual Financial Statements including Appropriation Accounts for such cancelled Ministries. The General Treasury having studied on the Ministries to which the subjects of previous expenditure heads of the Estimate 2018 were assigned, has concluded regarding the most appropriate new Ministries to prepare final accounts related to the allocations of such cancelled Ministries. Accordingly, the responsibility to prepare Annual Financial Statements for previous Ministries in 2018 depicted on the right side of the Annexure 1 herewith is assigned to the Secretary to the new Ministry depicted on the left side.

02. It is the responsibility of the Chief Financial Officer of the Ministry to which relevant subject is assigned to prepare Annual Financial Statements for previous expenditure heads in such manner as specified herein and submit to the Secretary to the Ministry.

03. Accordingly, Annual Financial Statements for the year 2018 shall be prepared and submitted to the Auditor General by following the instructions of this circular and State Accounts Circular No: 267/2018 and dated 21.11.2018 on the preparation of Annual Financial Statements of 2018 issued by the Department of State Accounts.
