The Chairman, Standard High Level Procurement Committee on behalf of the Secretary, Ministry of Finance, Planning and Economic Development, invites sealed bids from eligible and qualified bidders for "Procurement of 100 Nos. Brand New 4000L Gully Emptier" for Ministry of Finance, Planning and Economic Development, Lotus road, Colombo 01.
- 2. Bidding will be conducted through the National Competitive Bidding procedure.
- 3. Qualification requirements to qualify for contract award include:
 - I. The bidder and subcontractor shall provide documentary evidence demonstrating experience in supplying and maintaining the offered make of Brand-New Gully Emptier during the last <u>ten (10)</u> years.
 - II. The bid shall be accepted only from an Authorized local agent nominated by the respective Manufacturer of Chassis - Cab (Main Bidder or JV lead Partner). Documentary evidence for the appointment as an Authorized local agent for the offered brand over the last ten (10) years shall be provided.

1. Evaluation Criteria (ITB 35.3 (d))

The Purchaser's evaluation of a bid may take into account, in addition to the Bid Price quoted in accordance with ITB Clause 14, one or more of the following factors as specified in ITB Sub-Clause 35.3(d) and in BDS referring to ITB 35.3(d), using the following criteria and methodologies.

(a) Delivery schedule

The goods covered under this invitation are required to be delivered in partial shipments, as specified in the Schedule of Requirements. Bids offering deliveries earlier or later than the specified deliveries will be adjusted in the evaluation by adding to the bid price a factor equal to a percentage, specified in the Bid Data Sheet, of price per week of variation from the specified delivery schedule
