Information Technology Management Circular No.: 01/2024

All Secretaries to Ministries

Chief Secretaries of Provincial Councils

Heads of Departments/ District Secretaries

Heads of State Corporations, Statutory Boards, State Banks, Universities and Higher Education Institutions and Chairpersons of State Owned Enterprises

Mandatory Inclusion of National Identity Card Number/ Passport Number/ Company Registration Number into the Government Information Technology Systems as applicable, in order to enhance the efficiency and quality of the Public Services

The Cabinet of Ministers, at its meeting held on 05th August 2024, has granted approval to the Cabinet Memorandum No. 24/1488/604/161 dated 24.07.2024 submitted by the Minister of Finance to make it compulsory to include **National Identity Card Number/ Passport Number/ Company Registration Number** for the Government Information Technology Systems as applicable in order to enhance the efficiency and quality of the Public Services.

- 02. Accordingly, all Public Sector Institutions, including State Corporations and Statutory Boards, shall:
 - Develop the existing information systems and;
 - Design and develop the proposed future information systems

to ensure compliance with the mandatory inclusion of information related to Items I to III below for the identification of individuals and institutions.

- It is compulsory to enter the National Identity Card Number* to recognize the identity of
 the Individuals who have the Sri Lankan Citizenship/ Dual Citizenship (Residing in Sri
 Lanka/ Residing outside Sri Lanka).
- II. It is compulsory to enter the **Passport Number** along with the **Nationality** to recognize the identity of Foreign Nationals.
- III. It is compulsory to enter Company / Business Registration Number along with National Identity Card Numbers of the individuals who belong to Category I and the Passport Numbers with Nationality of the individuals who belong to Category II with respect to the owners/ the members of the Board of Directors of the said institutions in order to recognize identity of institutions.

[*The National Identity Card Number shall have the meaning that the National Identity Card Number currently being in use which has been issued by the Commissioner General of Registration of Persons or any National Identity Card Number proposed to be introduced in the future in this respect.]

- O3. All Heads of Institutions should ensure to take action during the year 2025 to develop the existing information technology systems as well as the information technology systems being at the developing / planning stages to a level that satisfy the conditions mentioned in paragraph 02 above and to include the requisite financial provisions in this respect into the Budget Estimates for the year 2025 and the Medium Term Budgetary Framework for the years 2026 and 2027 in terms of Section 03.1(i) I of the National Budget Circular No. 02/2024 dated 12.08.2024.
- O4. All Heads of Institutions should take action to comply with the provisions of the **Personal Data Protection Act, No. 09 of 2022** and the instructions provided under the **Circular No. MOT/2023/02 dated 21.09.2023 of the Ministry of Technology**, when entering data into the information technology systems and maintaining the same and ensure data standardization enabling to share the entered data with the other Public Sector Institutions.
- 05. Prior to make developments pertaining to the information technology systems of your institution as mentioned in paragraph 02 above, the officers listed below in the respective institutions should be contacted for coordination of work related to online information sharing.
