- Increase employability of graduates from 59.9% in 2022 to 64%.
- Increase student satisfaction on higher education among the undergraduates from 65% in 2022 to 85%.
- Increase Labour force participation with higher education qualification; male from 83% in 2023 to 84%, and female from 83% in 2023 to 84.5%.
- Improve the universities to achieve higher grading international ranking from No. of 11 in 2023 (out of 17) to 14, based on webometrics units.
