SRI LANKA EXPORT DEVELOPMENT ACT, No. 04 OF 1979

Order under Section 14

BY virtue of the powers vested in me by Section 14(1) of the Sri Lanka Export Development Act, No. 40 of 1979, I, Rishad Bathiudeen, Minister of Industry and Commerce with the concurrence of the Minister of Finance and Planning, do by this order declare that, a Cess shall be charged, levied and paid on import of any article specified in the Column II and Column III, at the rates specified in the corresponding entry in Column IV in the Schedule hereto, with effect from 2014.01.21. Accordingly, the respective Cess rates for articles specified under HS Heading 3920.49.20, 5601.21.10, 5601.22.10, 5601.29.10, 9619.00.10 and 9619.00.90 mentioned in Gazette Extraordinary, No. 1837/30 dated 21.11.2013 are hereby revised with effect from 2014.01.21
