The point to point inflation decreased to 4.1 per cent in December 2016. The annual average 3.7 per cent in December 2016. Core inflation that measures the price movements of the items in the CCPI basket excluding fresh food, energy, transport, rice and coconut, increased to 6.3 per cent, on point to point basis, while annual average core inflation increased to 5.1 per cent, in December 2016. The National Consumer Price Index (NCPI) covering price movements in all provinces of the country decreased to 4.1 percent in November 2016, on year on year basis.

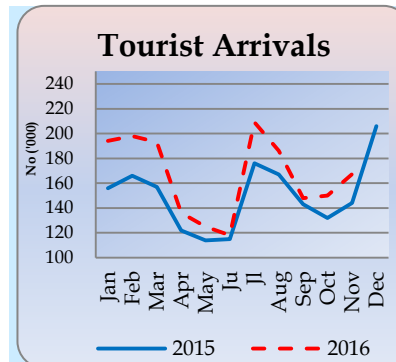


- Export earnings during January to September 2016 declined by 3.0 percent, compared to the respective period of 2015. The earnings for the month of September increased by 5.7 percent on year on year basis, reflecting the positive contribution from agricultural, industrial and mineral exports.
- On a cumulative basis, expenditure on imports decreased by 1.7 percent for the period during January to September 2016. Expenditure on imports for the month of September 2016 recorded 2.5 percent decreased over the corresponding month of 2015 despite the in imports of consumer and intermediate goods.
- Trade deficit was US\$ 6,182.6 Mn during January to September 2016 remained almost unchanged in comparison to the same period of 2015.

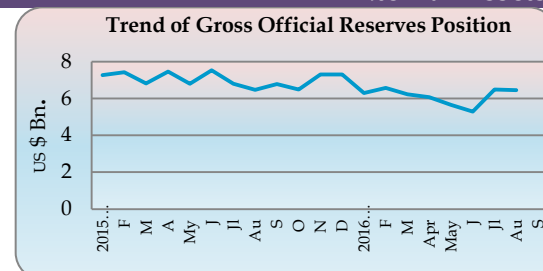

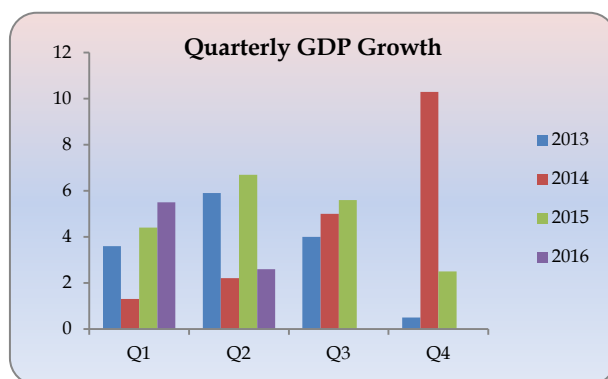

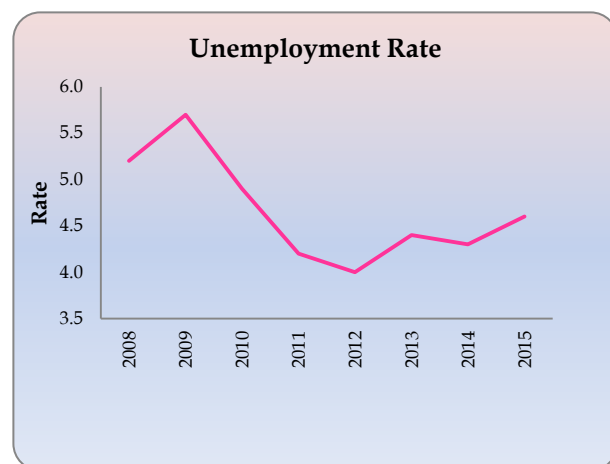
