Operating Guidelines for Importation of Essential Goods under Indian Credit Facility

This has reference to the letter No. MF/ICFCU/02/2022 dated 31.03.2022 on the above.

2. Subsequently, the Section 4.3, 10.4 (b) and 11.2 of the Operating Guideline forwarded with the referred letter are hereby amended as follows.
