Procurement of Minting and Supplying of Circulation Coins for the
Central Bank of Sri Lanka (2026-2028)

The Central Bank of Sri Lanka (CBSL) invites sealed bids from eligible and qualified coin manufacturers (Mints) for the minting and supply of circulation coins in accordance with the technical specifications and requirements set out in the Bidding Documents.

1. Scope of the Supply

The successful bidder(s) shall be required to manufacture, package, and deliver circulation coins as specified in the bidding documents. The scope includes, but is not limited to:

1.1 Production of circulation coins in the denominations and quantities specified below:

Denomination of Coin	Quantity (Million pieces)
Rs.10	165
Rs.5	170
Rs.2	45
Re.1	45
Total	425

1.2 Manufacture in accordance with the prescribed technical specifications and quality standards.

1.3 Packaging and secure transportation to the designated delivery destination.

1.4 Provision of quality assurance documentation.

2. Eligibility Criteria

The bidder shall be a legally established mint authorized to manufacture and supply coins.

3. Bidding Documents

A complete set of bidding documents in the **English Language** shall be obtained by interested bidders by submitting a written request via official email to coins2026@cbsl.lk with a copy to crdproc@cbsl.lk, accompanied by a scanned copy of the original letter of request issued on company letterhead and duly signed by an authorized officer of the company. 4. Pre-Bid Meeting

A pre-bid meeting will be held on **21 August 2026 at 1400 hours (Sri Lanka Standard Time)** at the **Central Bank of Sri Lanka, No. 30, Janadhipathi Mawatha, Colombo 01, Sri Lanka** and **both physical and virtual participation will be facilitated**. Prospective bidders are encouraged to attend the pre-bid meeting; however, attendance is not mandatory. Below mentioned details of the pre-bid meeting attendees shall be forwarded to coins2026@cbsl.lk with a copy to crdproc@cbsl.lk, on or before **19 August 2026 at 1000 hours (Sri Lanka Standard Time)**.

- The physical attendees shall submit Name and National Identity Card/Passport number of the attendee(s), Company Name and Contact Number.
- Virtual attendees shall forward the name, representing institution, email, and contact number of the attendee(s) to obtain the Microsoft Teams meeting link.

5. Submission of Bids

Completed bids shall be delivered to 'The Chairman, Procurement Committee, Central Bank of Sri Lanka, No. 30, Janadhipathi Mawatha, Colombo 01, Sri Lanka' by physically or electronically before **1400 hours (Sri Lanka Standard Time) on 18 September 2026**. **Electronic bid submissions shall be made via email to coins2026@cbsl.lk with a copy to crdproc@cbsl.lk**. Late bids shall be rejected.

6. Bid Opening

Bids shall be opened at **1430 hours (Sri Lanka Standard Time) on 18 September 2026** in the presence of the bidders' representatives who choose to attend in person at the CBSL or virtually (online).
