REAL SECTOR

- Economy expanded by 5.3 percent in the 1st quarter 2024.
- Price of Brent Crude Oil declined by 2.22 USD bbl and WTI declined by 4.30 USD bbl, respectively.
- CCPI - Headline (2021=100) increased to 1.7 percent (YoY) in June, 2024 from 0.9 percent (YoY) in May, 2024
- NCPI - Headline (YoY%) (2021=100) declined to 2.4 percent (YoY) in June, 2024 from 1.6 percent (YoY) in May, 2024

GDP expanded by 5.3 % in 1st Quarter 2024

In the first quarter of 2024, the Sri Lankan economy experienced a growth of 5.3 percent, a notable improvement from the 10.7 percent contraction recorded in the same period of 2023. This expansion was observed across all economic sectors recording a 1.1 percent, 11.8 percent, and 2.6 percent growth in the agriculture, industry and services sectors, respectively.

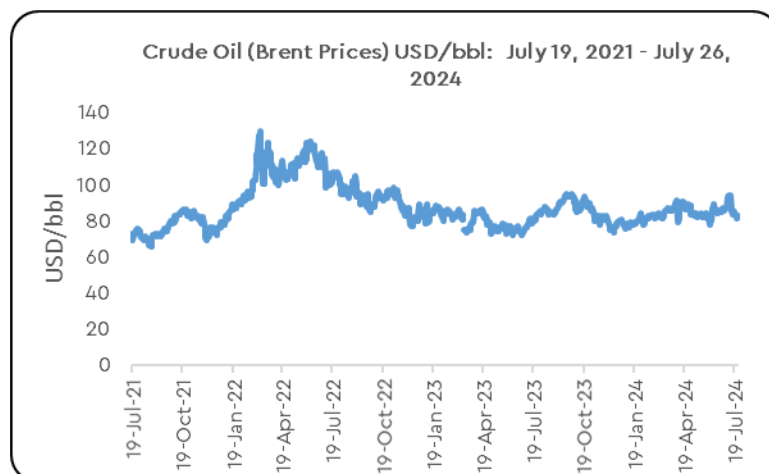

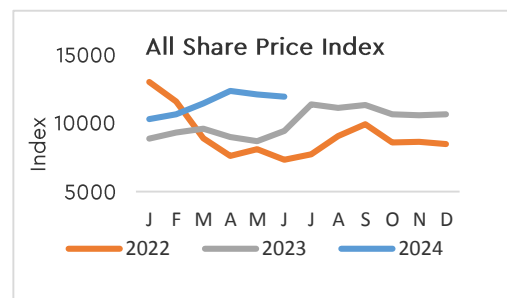
