Divestiture of Canwill Holdings (Pvt) Limited

The Government of Sri Lanka ("GoSL") announced its intention to divest 100% of its shareholding in Canwill Holdings (Pvt) Ltd, the parent company of Sinolanka Hotels & Spa (Pvt) Ltd and Helanco Hotels & Spa (Pvt) Ltd on 24th December 2025, as part of its ongoing State-Owned Enterprise reform and divestment programme.

The divestiture will be carried out through a two-stage competitive process, beginning with the invitation of Expressions of Interest from eligible local and international investors.
