Excise Ordinance

Excise Notification No.926

By virtue of the powers vested in me by Section 25 read with Section 32 of the Excise Ordinance

(Chapter 52) as amended from time to time, I, Mahinda Rajapaksa, Minister of Finance and

Planning, do by this notification declare that the guidelines and conditions, published in the

Excise Notification, No.902, appearing in Gazette Extraordinary, No: 1544/17 of 10th April 2008

are hereby amended as follows with effect from 23.11.2010.

1. The License fees shown in the Schedule I of the aforesaid Notification are amended

as shown in the Schedule I of this Notification.

2. By the deletion of paragraph 29 of Schedule III of the aforesaid Notification and the

substitution in its place the following:-

"where the transferee is not a legal heir of the transferor, a further sum of

Rs.1,500,000/- shall be paid in the case of FL 04 type licenses and Rs.200,000/-

shall be paid in other types as fees for transfer of the license to such transferee."
