Assistant Commissioner of Welfare (Project Finance Management & Reporting) and Assistant Commissioner of Welfare (Finance) -

Monthly Remuneration:

[91,690 – 10 x 2,480 - 15 x 3,450 – 168,240] + Government-approved allowances, 8% of the salary has to be contributed to the Employees' Provident Fund, and the Welfare Benefits Board will pay 12% as a government contribution. Further, a contribution of 3% to the Employees' Provident Fund is paid by the Welfare Benefits Board.
