The Week in Review
01st September – 04th September 2025

REAL SECTOR

- Economy expanded by 4.8 percent in the first quarter of 2025.
- Price of Brent Crude Oil decreased by 0.89 USD bbl and WTI decreased by 0.52 USD bbl, respectively.
- CCPI - Headline inflation (2021=100) increased to 1.2 percent (YoY) in August, 2025 from -0.3 percent (YoY) in July, 2025.
- NCPI - Headline inflation (2021=100) increased to 0.7 percent (YoY) in July, 2025 from 0.3 percent (YoY) in June, 2025.

- Exports increased to USD 1,302.2 mn in July 2025 compared to USD 1,141.8 mn in June 2025.
- Imports increased to USD 1,882.2 mn in July 2025 compared to USD 1,682.1 mn in June 2025.
- Trade deficit
 - USD 580.0 mn in July, 2025
- The gross official reserves stood at USD 6.1 bn as end of July 2025.
- Workers' remittances recorded USD 680.8 mn in August 2025.

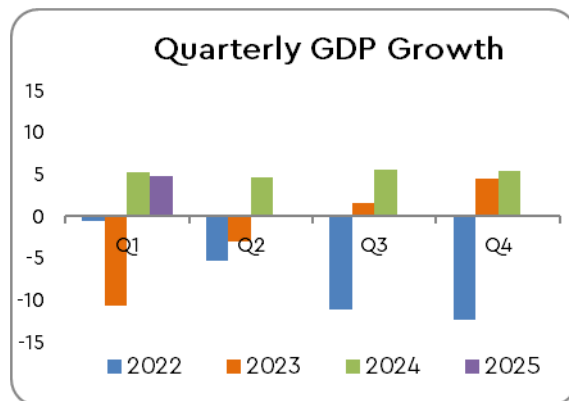

GDP expanded by 4.8 % in 1st quarter 2024

In the first quarter of 2025, the Sri Lankan economy experienced a growth of 4.8 percent, compared to 5.1 percent growth recorded in the same period of 2024. This expansion was observed recording a 9.7 percent and 2.8 percent growth in the industry and service sector, respectively. Agriculture sector contracted by 0.7 percent.

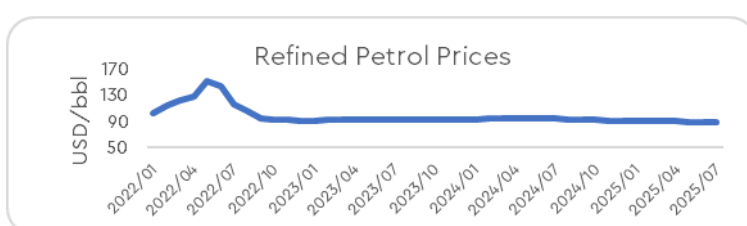

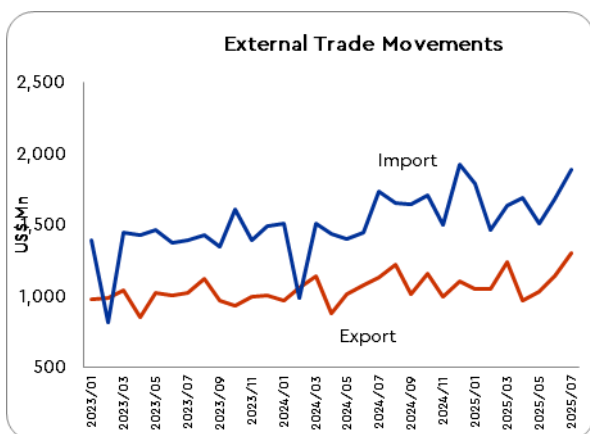
