REAL SECTOR

- Economy expanded by 5.5 percent in the 3rd quarter of 2024.
- Price of Brent Crude Oil declined by 4.47 USD bbl and WTI declined by 3.58 USD bbl, respectively.
- CCPI - Headline inflation (2021=100) declined to -4.2 percent (YoY) in February, 2025 from -4.0 percent (YoY) in January, 2025.
- NCPI - Headline inflation (2021=100) declined to -4.0 percent (YoY) in January, 2025 from -2.0 percent (YoY) in December, 2024. [More on this on page 2](#)

- Sri Lankan rupee slightly depreciated to USD 1=Rs. 295.57 from USD 1=Rs. 295.47
- Exports declined to USD 1.05 bn in January 2025 compared to USD 1.10 bn in December 2024.
- Imports declined to USD 1.79 bn in January 2025 compared to USD 1.92 bn in December 2024.
- Trade deficit
 - USD 732.7 mn in January, 2025
- The gross official reserves stood at USD 6.1 bn as end of January 2025.

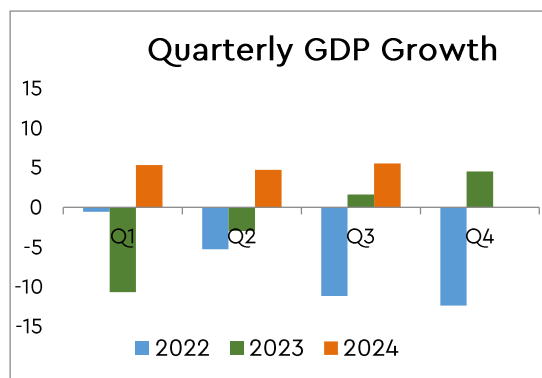

GDP expanded by 5.5 % in 3rd Quarter 2024

In the third quarter of 2024, the Sri Lankan economy experienced a growth of 5.5 percent, a notable improvement from the 1.6 percent contraction recorded in the same period of 2023. This expansion was observed across all economic sectors recording a 3.0 percent, 10.8 percent, and 2.6 percent growth in the agriculture, industry and services sectors, respectively.

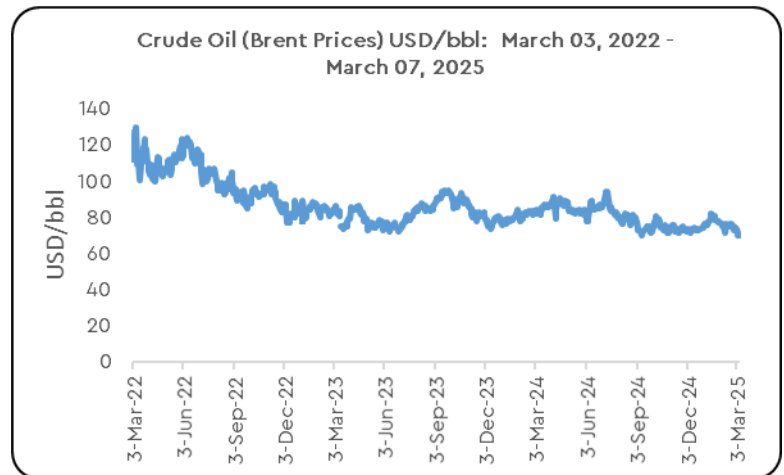
