To all Secretaries to Ministries. Chief Secretaries of Provincial Councils Heads of Departments, District Secretaries Chairpersons of State Corporations, Statutory Boards, Authorities and Govt. Owned Companies

Fitness Test and Maintenance of Government Owned Vehicles (Vehicle Emission Test)

All types of Government owned vehicles such as motor cars, lorries, buses, vans and motor cycles shall be maintained in conformity with the exhausting emission standards published in the Government Gazette dated 30th June 2003, pursuant to the provisions in the National Environment Act No. 37 of 1980.

- 02. Accordingly, all types of vehicles belonging to your institution should be tested annually by an institute of Exhausting Emission Testing in conformity with terms and standards given in the above Gazette notification and a certificate should be obtained in that respect. The services of the following registered institutions can be obtained in order to get this test properly and easily conducted.
